<b>First Duty Station Enlisted</b>	Classroom Instruction provided at First Term Airman Center (FTAC)	None	Regular AF within 90 days of arrival Reserve Component 120 days of arrival (not required for reservists who were prior active duty or prior enlisted)
<b>First Duty Station Officer</b>	Classroom Instruction or appointment at M&FRC	None	Regular AF-within 90 days of arrival Reservists-within 120 days of arrival (not required for reservists who were prior active duty or prior enlisted)
<b>Promotion (E1-E5 and O1-O4)</b>	Classroom Instruction or appointment at M&FRC	My Vector	Completed 90 days before promotion to 90 days after promotion
<b>PCS (E1-E4 and O1-O3)</b>	Classroom Instruction included with Smooth Move PCS Workshop at M&FRC	My Vector	Prior to out-processing E4/O3 & below
<b>TSP Vesting (Retirement Planning Starter)</b>	Classroom Instruction or appointment at M&FRC	My Vector	60 days before and up to 180 days after Airman's 25th month of service
<b>Continuation Pay</b>	None	MYPERS	Airman under the Blended Retirement System, No earlier than 90 days and no later than one day prior to the years of service requirement for continuation pay
<b>Lump Sum</b>	Appointment at M&FRC	None	Prior to election of option
<b>Pre-Deployment</b>	Appointment at M&FRC	My Vector	No earlier than receipt of deployment orders and no later than prior to deployment. Training is current for 3 years and remains current throughout the period of deployment.
<b>Post-Deployment</b>	Classroom Instruction included with Reintegration Briefing at M&FRC	My Vector	Within 30 days of return from deployment. Training valid for 3 years.
<b>Birth of First Child</b>	Classroom Instruction included with Bundles for Babies Workshop or appointment at M&FRC	My Vector	No earlier than 6 months prior and no later than 90 days after updating DEERS with first dependent child. This applies to any child under 18, including those adopted & stepchildren.
<b>Marriage</b>	Appointment at M&FRC	My Vector	No earlier than 6 months prior and no later than 90 days after updating DEERS to married status for the first time.
<b>Divorce</b>	Appointment at M&FRC	My Vector	No earlier than 6 months prior and no later than 90 days after updating DEERS to divorced status for the first time.

**Retirement/Separation/AD to RC:** as described in TAP guidance

**Disabling Sickness/Condition:** when identified as wounded, ill, or injured through RCC

**EFMP:** financial readiness reviewed by EFMP-FS during family needs assessment
